## Town of Blue Hill 2024 Special Town Meeting WARRANT

To: Michelle Rockwell, a resident of said Blue Hill, in said County.

Greetings: In the name of the State of Maine, you are hereby required to warn and notify the voters of Blue Hill, in said County, qualified by law to vote in Town affairs, to meet in the Select Board Room at the Town Hall, Blue Hill, on Monday June 24, 2024 at 5:30 pm, then and there to act on the following articles to wit:

Article 1- To choose a moderator to preside at said meeting.

Article 2- Shall the Town appropriate \$137,000 from undesignated fund balance and authorize the School Committee to expend those funds as it deems necessary for Facilities Maintenance, in addition to amounts previously authorized for the Facilities and Maintenance cost center and total school budget for Fiscal Year 2024 (Articles 14 and 19)?

Explanation: The School Committee intends to use these funds to complete the upgrades to the school roof, replace the hydronic expansion tank, replacing the cafeteria tables, replacing broken school lockers, and adding cell phone lockers to the school building.

Article 3- Shall the Town appropriate \$27,500 from undesignated fund balance and authorize the School Committee to expend those funds as it deems necessary for Regular Instruction, in addition to amounts previously authorized for the Regular Instruction cost center and the total school budget for Fiscal Year 2024 (Articles 7 and 19)?

Explanation: The School Committee intends to use these funds to upgrade staff laptops.

Article 4 - To see if the Town will vote to reclassify the following expenditures from the Select Board appropriation for unanticipated expenses and emergencies (Article 43 from the 2024 Annual Town Meeting Warrant) increasing the specified appropriation for each item and to appropriate \$5,511.85 from Unassigned Funds for unanticipated expenses and emergencies (as described in Article 43):
