ARTICLE 3. GSA Excess Charge - Shall the Town raise and appropriate \$164,900 from Property Tax in Excess Tuition Charges for George Stevens Academy (in excess of the maximum allowable tuition and Insured Value Factor payments set by the state) and authorize the School Committee to pay George Stevens Academy during the school fiscal year 2025-2026 an additional \$1,700 per student, for up to 97 students, the maximum number of Blue Hill students estimated to attend George Stevens Academy during the 2025-2026 school year? All such amounts appropriated will be additional local funds which exceed the state's Essential Programs and Services allocation model for this purpose.
